# FWT Board Meeting August 8, 2022

### A. Administrative Tasks

  - a Town Recovery grant was received.
  - b Upcoming expense: Replacement of two orange trail boardwalks, just west of the red trail, in WRNP, including demolition and new construction of a wider boardwalk, expanding from 2 feet to 4. **ACTION ITEM**: Craig to see if there's a scout available to do the work.
  - c Youth Coordinator position: Posted July 27, but no interest so far. Will need someone to pitch in to cover this role. ACTION ITEM: Craig will ask local troops for someone to do the role temporarily, including having tools to do the work and supervision of the work.

# **B. Main Topics**

### 1. Trails Planning & Maintenance: -

Maintenance: Planning - Craig, Hal, Steve

- o Mowing volunteer calendar: No mowing needed until we get the trailer.
- o Trailer Status no update

- Trail Workday #6: Four Mile Creek, July 16 Dennis. RL Thomas XC team completed clearing new orange trail and spreading stone. Dennis contacted Glenn Morrell about blaze paint or badges of some sort to mark the new orange trail. **ACTION ITEM:** Norma and Craig to work on mapping of orange trail.
- Trail Workday #7: Whiting Rd Nature Preserve, August 20 Craig to coordinate stone spreading at 9:00am. Wheelbarrows are needed. Cross Country team will contribute some help.
- Trail Workday #8: Tree Planting, Sept 17 Norma: Rotary plans to help.
- Hojack Trail update (Planning mtg to be scheduled) Anna: Meeting to come, with discussion of the trail condition of each segment of the trail. The meeting will include Matt from RGE. ACTION ITEM: Anna to schedule meeting.
- Lost & Found basket- Anna: Glenn Morrell approved putting a basket on each kiosk. Process: Trail stewards will regularly (but not daily) check the basket. Valuable items will be bagged in a transparent bag, marked with the trail the item was left at, and taken to the Parks & Rec office. **ACTION ITEM:** John B will communicate the policy to trail stewards.
- Trails/Trail Maps: update for M Johnson and Eckler Property Norma & Dennis: A map of the trail is ready for the Website. An entrance archway with signage is in the works with materials already purchased. A plaque like the one at the John Unger trail is in process. A dedication hike/event can be done in the future. **ACTION ITEM**: Norma to provide map files to Steve for Website.
- Counting Trail usage Sarah: Purpose is to understand usage for resource allocation, perhaps especially for prioritizing trails with the town. Proposals: (a) purchase a trail counter for accurate counting; (b) do visual counting at a sampling of days/times on trails; (c) use a trail camera to count users; or (d) not do counting. Decided to do a counts in some way at WRNP and FMC, but the process is still to be decided. Continue discussion next month.
- Grants: Status of Awards/Next Steps Hal, Norma, Anna. Town Recovery Grant funds and Rotary grant funds received. Need to provide recordkeeping for Rotary grant.

  ACTION ITEM: Anna to communicate with Rotary about exact documentation needed.
- Tools management. Hedge trimmer needed: should FWT buy the tools? Estimate of cost is \$350 for cordless trimmer with 2 batteries.
  - i. Vote on purchase Approved. **ACTION ITEM:** Craig to purchase.
  - ii. Need to establish a central location for tool storage or a tracking process/sign out process. Suggest adding an administrative item to agenda for tool tracking. ACTION ITEM: Anna to circulate to Board a spreadsheet for establishing a tool inventory.
  - iii. Display materials will not be part of tool tracking. Those will be transferred to John's house.
- 2. **Re-Tree Project:** Norma/Sarah: September work party will be to plant the specimen plot in Whiting Road and the east end of the Johnson trail. The work will include planting the trees and installing protection fencing.
- 3. **Promote:** Anna T.
  - Group Hikes: 2022 o Monthly Hike: Whiting Rd Nature Preserve, July 23,2022 10:00am: The day was very hot, and only 1 person attended. The August hike will be earlier in the day to beat the heat.

- Website- Proposed updates- Anna. Want to add drop down for ReTree materials. **ACTION ITEM:** Norma and Sarah to work with Steve to add materials.
- Recruitment -Anna: No interest yet. **ACTION ITEM:** Anna will post on Linked In.
- Annual Meeting Anna: Planning process starting, with the idea of having a speaker attend. Anna has some ideas, but all should send ideas to Anna. Location will be Finn Park lodge again.
- Car Hike redux proposed for November 5.

#### 4. Open Space:

Open Space – Status - Hal. Town was awarded DEC Community Forest Grant \$280k to acquire the Woods property off Herman Rd, which will enable a second entrance for Whiting Road. Mary Donbovy will fund the difference in purchase price from the grant. After completion of purchase, several projects will be needed: construction of trails and boardwalks; construction of 8-car parking lot off Herman Rd; and ReTree work to clear invasives and do planting near road.

## 5. **Open Discussion**

State Rd. bridge construction remains an open question, with permits needed for construction in a wetland. Given the residents' opposition, this project will be held.
